- Security will be provided 24 hours starting 7:00 P.M. August 14 to 7:00 A.M. August 15. Merchandise left on the festival grounds will be at owner's risk.

- Vendors will be given ONE parking pass for a designated parking lot after setup. No on-site camping permitted.

- Outside vendors must bring their own tent with a tag stating that it is flame retardant for AA Co Fire Marshall inspection.
